Receive chargebacks from CIT electronically and automatically update the PAS Accounts Receivable files.

#### **Groupe BDM Sales Rep Order Entry**

Remote Order Entry for Sales Reps. Orders are entered on a Palm device and uploaded to Groupe BDM servers for transfer to your computer. Orders are edited for accuracy and processed into the PAS order files. Keying of orders is eliminated.
